Please read the following carefully before signing:

Membership in the G2 Cycling Team/Club (hereafter known as "Team/Club") is voluntary and is dependent upon the member adhering to standard rules of bicycle road conduct, including the Florida Uniform Traffic Control Law. Membership is open to riders age 18 and over. Racing is not required of members and is voluntary.

As a member of G2 Cycling Team/Club, I will be participating in group rides, activities, and possibly races. I may also wear the G2 jersey and racing kit. I understand that members are not paid or otherwise reimbursed in any manner for their participation in the Team/Club or any of its activities and races.

Membership and/or wearing the Team/Club uniform does not imply any relationship whatsoever with G2 Health, Gentisse Cosmetic Surgery, Beyond Beauty Cosmetic Surgery, P.A., Anesthesia Etc. Corp., or any other advertisers or sponsors (collectively Releasees).

I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in riding with, and being a member of, G2 Cycling Team/Club, whether as a rider, coach, mechanic, volunteer, or otherwise. I fully assume the risks associated with such participation including and not limited to: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, including potholes; equipment failure, inadequate safety equipment, use of equipment or materials provided by the Team/Club and others; the releasees' own negligence, the negligence of others and weather conditions; and the possibility of serious physical and/or mental trauma or injury, or death associated with cycling. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I hereby waive, release, discharge, hold harmless, and promise to indemnify and not to sue the G2 Cycling Team/Club, the Releasees, and all advertisers, sponsors, organizers, team leaders and promoting organizations that are in any manner connected with the Team/Club from any and all rights and claims including claims arising from the Team/Club's own negligence, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the Team/Club, or travel to or return from any cycling or Team/Club event.

I agree, that for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim contrary to what I have agreed to in this contract, the claiming party shall be liable for the expenses (including legal fees) incurred by the Releasees in defending the claims. This contract may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as a consent to any subsequent waiver or modification. Every term and provision of this contract is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
